PROPOSED TAX RATE REDUCTIONS BEGINNING IN FY26

Mayor Parker has proposed an unprecedented \$212M tax investment through FY30, including about \$17M in FY26

WHAT IS PROPOSED?

Business Income & Receipts Tax (BIRT)

Starting in FY26, reduce the Net Income portion of the tax to 5.5% in FY30, down from 5.81% today. Then more aggressive reductions to 2.8% by FY39.

Beginning in FY26, the Mayor proposes reducing the rate of the Gross Receipts portion of the tax incrementally until it is completely eliminated by FY39.

Eliminate the \$100,000 statutory deduction for Tax Year 2025, which is due by April 15, 2026.

Wage Tax

Reduce the rate for Philadelphia residents to 3.7%, down from 3.75%, and for Non-Residents 3.44% to 3.39% over the next five years. This will also affect the Net Profits Tax and the School Income Tax, as both of these taxes match the Wage Tax rate.

Real Estate Tax

Shifting the millage rate to increase funding for public education by \$12M; effective in FY30.

Use & Occupancy Tax (U&O)

Eliminate the \$2,000 exemption for Use & Occupancy Tax, beginning January 1, 2026.

PHILADELPHIA BUSINESS TAX CHANGES ARE COMING



Get your business ready

WHAT IS PROPOSED?

Since Tax Year 2016, one of Philadelphia's most important business tax policies has exempted the first \$100,000 of Philadelphia receipts when filing the Business Income and Receipts Tax (BIRT). This exemption significantly reduces the tax burden for small businesses. Additionally, the School District has provided a \$2,000 annual exemption on the Use & Occupancy Tax.

Unfortunately, due to a legal challenge and a ruling from the PA Supreme Court, the City can no longer offer these exemptions.

Beginning in Tax Year 2025, businesses will no longer receive the \$100,000 exemption.

Beginning January 2026, taxpayers that use or occupy, property for business purposes will no longer receive a \$2,000 annual exemption. Commercial landlords should begin to plan for this change.

WHAT DO YOU NEED TO KNOW?

Begin tax planning now for changes to the BIRT when you file your taxes for business activity from 2025 in April 2026. You may not have had to file or pay a BIRT return in the past. Plan now for changes to U&O exemptions, which begin January, 2026.

Although your BIRT bill may increase, your Net Profits Tax will likely decrease. That's because you receive a credit on the NPT worth 60% of what you paid on the Net Income portion of the BIRT. (If you pay more BIRT, your credit will also increase.)

Don't forget, Philadelphia allows businesses to carry forward losses for twenty years. Your business is unique, we recommend you work with a tax professional who understands your business.
